We invite you to support the Juneau Skating Club in 2026! With a mission to “teach Juneau to skate,” JSC offers Learn to Skate classes to all ages and skill levels. JSC also runs a vibrant figure skating program which sends skaters and synchronized skating teams to multiple competitions every season. And, every year JSC produces two shows – a holiday recital that is free to Juneau audiences, and a themed Spring Show that both showcases all JSC skaters and brings world-class guest skaters to perform in Juneau.

There are multiple ways to contribute to our program: 1) annual club sponsorship, 2) business ad or logo purchases for the Spring Show program, 3) personal message digital ad on the Treadwell lobby TV during the Spring Show, 4) monetary donations, or 5) donations to our silent auction.

Every dollar raised goes to JSC’s Learn to Skate program and figure skating program. Your contribution helps fund ice rental fees, coach fees, scholarships for skaters who need financial assistance, and travel expenses – for both our skaters and guest skaters. Every year costs rise, but it’s our fundraising that keeps us from having to raise class prices. With the raised rental rates for *next season*, JSC will pay an additional \$17,000 in ice rental fees, to put that into perspective.
